CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely, Bharathiyar College of Education, Ammampalayam Post, Attur Taluk, Salem District-636141, TamilNadu vide SRC (NCTE) order no. F.TN/SEC/SRO/NCTE/2005-2006/1535 dt. 13.07.2005 conducting B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2005-2006.
